: ORDERS ON I.A. NO. 1 Perused the plaint averments, contents of I.A.I filed under Order XXXIX Rules 1 and 2 r/w. Sec. 151 of CPC, annexed affidavit and the documents produced. Plaintiff through I.A. No. 1 is seeking an ad interim ex parte order of temporary injunction restraining the defendants, their agents, assignees, their representatives, or any other persons or entities acting under their authority or instructions including content commentators, influences, anonymous users and similar participants from publishing, circulating, sharing, hosting, streaming, providing access to or other wise communicating any false, defamatory, derogatory, malicious material relating to the Plaintiff's film by name "Jetlee" and direct the defendants to de-index, de-reference and render non-searchable all existing defamatory content any substantially similar future links/URLs across search engines and internal Platform searches there by ensuring the permanent suppression of such material and further direct the defendants to block the defamatory or orchestrated negative responses or ratings uploaded any social media Platforms, web-sites or movie booking/rating portals whether in the form of text, voiceover, face-cam content, reaction videos, manipulated ratings or any other format including those listed in the schedule of the I.A. or located on any other URL or platform and restrain the defendants from reusing, republishing circulating or exploiting any photographs, clips, or footage from the Plaintiff's film "Jetlee" for defamatory, malicious or similar improper purposes and further restraining from engaging in, participating or facilitating orchestrated rating manipulation artificial bulk-based ticket feedback, coordinated down-ranking or any other activity intended to distort, diminish, or misrepresent the public perception, ratings or reception of the Plaintiff's film "Jetlee" pending disposal of the suit. Plaintiff has filed this suit against the defendants for injunction restraining defendants , their agents, servants, reviewers, influencers, You tube channels , critics, publications, portal or any other persons claiming through them from publishing, posting, sharing, uploading, streaming, commenting or circulating any false defamatory , derogatory, malicious, unverified and damaging reviews, comments, videos, reaction videos, community pools, boycott campaigns or malicious content regarding the Plaintiff's film "Jetlee" and other reliefs. Heard arguments of learned counsel for the plaintiff. Plaintiff at this stage appears to have made out prima-facie case and established the grounds against the defendants as the plaint averments and documents produced discloses that, there is a threat of propagating of defamatory and unverified statements against the Plaintiff's film "Jetlee" in the news channel and social media. The

plaint pleadings discloses that, plaintiff is the distributor of the movie by name "Jetlee"; and it is schedule to be released and he invested the huge amount for the distribution of movie. If the defendants posts any false and defamatory, unverified articles against Plaintiff's film "Jetlee", then definitely the image of the Plaintiff's film "Jetlee" will be damaged and it may cause huge loss to the Plaintiff. In the event of not restraining the defendants, the very purpose of filing of the suit will be defeated, causing loss to the plaintiff and also multiplicity of suit. Hence, proceed to pass the following:- ORDER Defendants, their agents, assignees, their representatives, or any other persons or entities acting under their authority or instructions including content commentators, influences, anonymous users and similar participants are hereby restrained by way of ad-interim ex-parte temporary injunction from publishing, circulating, sharing, hosting, streaming, providing access to or other wise communicating any false, defamatory, derogatory, malicious, unverified or harmful content including challenging feedback, trolling, false narratives, personal attacks, reaction videos, community polls, boycott campaigns or other malicious material relating to the Plaintiff's film by name "Jetlee" and also directed the defendants to de-index, de-reference and render non searchable all existing defamatory content any substantially similar future links/URLs across search engines and internal flat form searches there by ensuring the permanent suppression of such material and further directed the defendants to block the defamatory or orchestrated negative responses or ratings uploaded any social media Platforms, web-sites or movie booking /rating portals whether in the form of text, voiceover, face-cam content, reaction videos, manipulated ratings or any other format including those listed in the schedule of the I.A. or located on any other URL or platform and further restrained the defendant from reusing, republishing, circulating or exploiting any photographs , clips, or footage from the Plaintiff's film "Jetlee" for defamatory, malicious or similar improper purposes and further restrained from engaging in participating or facilitating orchestrated rating manipulation artificial bulk-based ticket feedback, coordinated down -ranking or any other activity intended to distort, diminish, or misrepresent the public perception, ratings or reception of the Plaintiff's film "Jetlee" till the date of next hearing. Plaintiff to comply provisions of Order XXXIX Rule 3(a) of CPC. Issue order of T.I. and notice on I.A.No.1 and suit summons to defendants, r/by 07-08-2026.
