Show around of Parliament for visitors during Inter-Session Period through Online Mode

Hon'ble Members are informed that they can now apply online for show around of Parliament for visitors/ guests by accessing <https://darshan.sansad.in> through their login credentials as in the case of Public Gallery Passes.

Show arounds of Parliament for visitors will be arranged as usual on all working days during inter-session between 10:30 hours and 17:30 hours except during weekends, gazetted holidays and up to 05 working days prior to the commencement of a session. No show around will be arranged during the Parliament session due to administrative and security reasons. During inter-session period, group show arounds are restricted to a maximum of 50 persons per requisition. It is advised that requests for group show arounds are made 3 working days prior to the visit to enable verification of antecedents. Show arounds will not be conducted if verification is not complete or the report contains adverse remarks.
