4. At the outset, this Court notes that respondent no. 2 is Goods and



Services Tax Appellate Tribunal (“GSTAT”).

5. Accordingly, respondent no. 2 is deleted from the array of parties.
6. Let amended Memo of Parties be filed, within a period of 10 days from today.
7. The present petition has been filed under Article 226 of the Constitution of India, 1950 (“Constitution”), seeking direction for modification in the time schedule fixed in the Notification dated 17th September, 2025, whereby the last date for filing of appeal before the GSTAT has been fixed as 30th June, 2026.
8. Learned counsel appearing for the petitioner submits that the said date of 30th June, 2026 seems to be unreasonable, having regard to the practical difficulties faced by the litigants and the professionals, due to piling of appeals over the years on account of non-functioning of the GSTAT.
9. Issue notice. Notice is accepted by learned counsels appearing for respondents.
10. Let reply be filed within a period of two weeks. Rejoinder thereto, if any, be filed within a period of one week, thereafter.
11. List before the Roster Bench on 27th July, 2026.
