I.A. 17302/2026 (Exemption)

1. Allowed, subject to all just exceptions.
2. Application stands disposed of.

I.A. 17301/2026 (for pre-institution mediation)

3. This application is filed on behalf of the Plaintiff under Section 12A (1) of the Commercial Courts Act, 2015 read with Section 151 CPC seeking exemption from Pre-Institution Mediation.
4. Having regard to the facts of the present case wherein urgent relief is prayed for and in light of the judgment of Supreme Court in *Yamini Manohar v. T.K.D. Keerthi*, (2024) 5 SCC 815, as also Division Bench of this Court in *Chandra Kishore Chaurasia v. RA Perfumery Works Private Ltd.*, 2022 SCC OnLine Del 3529, exemption is granted to the Plaintiff from Pre-Institution Mediation.
5. Application is allowed and disposed of.



I.A. 17303/2026 (u/O XI Rule 1(4) r/w Section 151 CPC)

6. This application is filed on behalf of the Plaintiff seeking time to file additional documents.
7. Plaintiff, if it wishes to file additional documents at a later stage, shall do so strictly in accordance with the provisions of the Commercial Courts Act, 2015.
8. Application is allowed and disposed of.

CS(COMM) 712/2026

9. Let plaint be registered as a suit.
10. Upon filing of process fee, issue summons to the Defendants through all permissible modes, returnable before the learned Joint Registrar on 14.08.2026.
11. Summons shall state that the written statements shall be filed by the Defendants within 30 days from the receipt of summons along with affidavit of admission/denial of the documents filed by the Plaintiff.
12. It will be open to the Plaintiff to file replications within 30 days from the date of receipt of written statements along with affidavit of admission/denial of documents filed by the Defendants.
13. If any of the parties wish to seek inspection of any documents, the same be sought and given within the timeline prescribed in Delhi High Court (Original Side) Rules, 2018.
14. Learned Joint Registrar will carry out admission/denial of documents and marking of exhibits.

I.A.17300/2026 (u/O XXXIX Rules 1 and 2 r/w Section 151 CPC)

15. This application is filed on behalf of the Plaintiff under Order XXXIX Rules 1 and 2 read with Section 151 of CPC for grant of *ex parte* ad interim injunction.



16. Issue notice to the Defendants through all permissible modes, returnable before Court on 04.11.2026.

17. Case of the Plaintiff as set out in the plaint is that Plaintiff is the largest retailer and leading manufacturer of footwear in India and is part of world renowned Bata Shoe Organization. Plaintiff owns numerous factories and/or manufacturing units in India where world-class footwear is manufactured and Plaintiff's factory at Batanagar was the first Indian shoe manufacturing unit to receive the ISO 9001 certification in 1993. Plaintiff has over 1400 retail outlets serving more than one million consumers every day. Globally, the Bata Group runs around 40 production facilities across 26 countries and manages a retail presence in over 120 countries and is a listed company in BSE and NSE.

18. It is stated that Plaintiff adopted the trademark BATA in 1931 and has been continuously and extensively using the same since then. By virtue of immense promotion and use of the mark and acclamation from members of the trade and public, the mark BATA has become synonymous with the Plaintiff, so much so that any goods bearing the said mark are instantly associated with the Plaintiff alone. Plaintiff also promotes its wide range of BATA products through its website www.bata.in, which is an interactive website accessible to the customers across India, including Delhi and was registered on 11.02.2005.

19. It is stated that in order to secure statutory rights in the mark BATA, Plaintiff applied for and obtained registrations in the mark as also its formative marks as follows:-

20. It is stated that the registrations are valid and subsisting and by virtue of these registrations, Plaintiff has acquired the exclusive right to use the marks and restrain third parties from using the same without its authorization. Plaintiff is a recipient of many prestigious awards globally and in India, the details of which are furnished in paragraph 15 of the plaint and illustratively, some of them are: "Top Most Trusted Brands" in 2012 and 2013 consecutively; and the Most Admired Fashion Brand of the Year in 2018. Plaintiff has extensively advertised and promoted the mark BATA in international and local media, including in magazines and television and has also collaborated with well known Indian celebrities such as Kriti Sanon, Disha Patani, Late Sushant Singh Rajput, Kartik Aaryan and Taapsee Pannu for brand endorsement. Sales of the Plaintiff have steadily increased many times over the last years, which is a reflection of its goodwill and reputation and the superiority of the brand BATA. The sales turnover are as follows:-

21. It is stated that the popularity enjoyed by the brand BATA is also evidenced by the large following amassed by the Plaintiff on its social media pages having approximately 9.1 million followers on Bata India's Facebook Page, 216k followers on Bata India's Instagram page and almost 16k on X. Plaintiff has also created Bata Worldwide/International accounts on the said social media pages to cater to the international audience with the Facebook page having 9.1 million followers, Instagram page having 179k followers and X page having 8.7k followers. Mark BATA has been declared as a well known mark by the Allahabad High Court in case titled ***Bata India Limited v. Pyare Lal & Co. Meerut City & Ors.*** in ***F.A.F.O No. 275 of 1984*** vide order dated 23.01.1985 and is included in the list of well-known marks by the Trade Marks Registry.

22. It is stated that during the third week of May, 2026, the authorized representative of the Plaintiff came across listing of Defendants No. 1 and 2 on platform of Defendant No. 3/Flipkart for sale of footwear under trademark BATA and Plaintiff issued cease and desist notice dated 21.05.2026 to Defendant No. 1. On 03.06.2026, Plaintiff placed an order and the product was delivered on 06.06.2026, on inspection of which it was found that the product was a counterfeit product and it was falsely stated that on the product that it was manufactured and marketed by the Plaintiff. Plaintiff conducted a search of the official website of the Trade Marks Registry but did not come across any registration or even a pending application for registration of the mark BATA in favour of Defendants No. 1 and 2.

23. Learned counsel for the Plaintiff submits that Defendants No. 1 and 2 are manufacturing, marketing and selling shoes bearing the mark BATA and

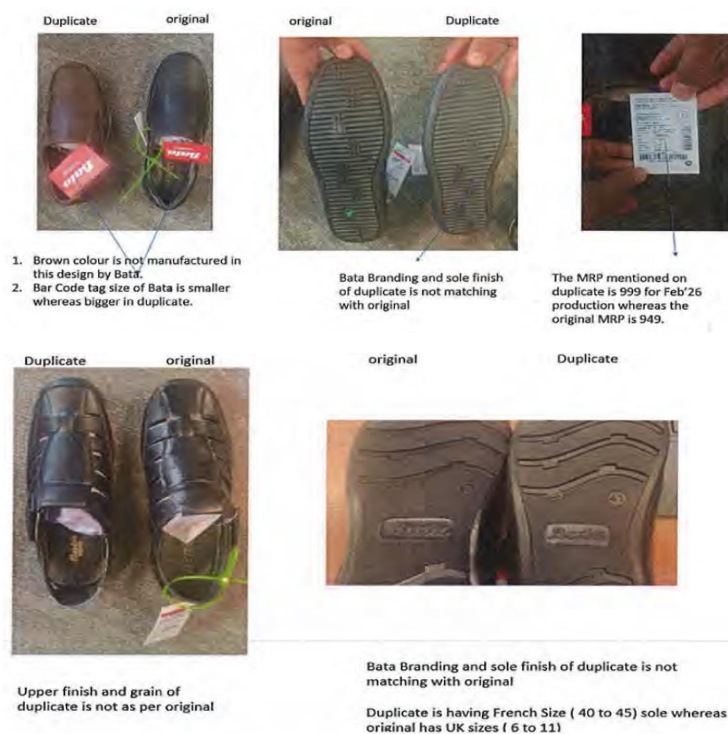


infringing the registered mark of the Plaintiff. It is clear that the activities are calculated to mislead and deceive unwary consumers into believing that the counterfeit goods originate from or are associated with the Plaintiff. The mark BATA has been declared as a well-known mark and its unauthorized use by Defendants No. 1 and 2 amounts to trademark infringement under Section 29 of Trade Marks Act, 1999 ('1999 Act') as also dilution of the mark. Plaintiff has garnered enviable goodwill and reputation over decades by selling its products under the mark BATA and intent of Defendants No. 1 and 2 is clearly to misrepresent to the public and encash on the goodwill and reputation of the Plaintiff for unlawful gains, which is causing irreparable harm and injury to the Plaintiff and amounts to passing off. Defendants are completely aware of the reputation of the Plaintiff as also its exclusive right over the mark BATA and yet have dishonestly adopted identical mark BATA to sell counterfeit products.

24. Having heard learned counsel for the Plaintiff and on examination of documents, I am of the view that Plaintiff has made out a *prima facie* case for grant of *ex parte* ad interim injunction. Balance of convenience lies in favour of the Plaintiff and it is likely to suffer irreparable harm in case *ex parte* ad interim injunction as prayed for, is not granted. Plaintiff is a registered proprietor of the trademark BATA and its formative marks, which have been used since 1931, when the mark was first adopted. Plaintiff sells a wide range of products under the said mark and the immense reputation and goodwill earned by the Plaintiff by sale of products under the mark BATA is reflected from the sales turnover. The distinctiveness attached to BATA is judicially recognized by the Allahabad High Court by declaring the mark as a well-known mark under Section 2(1)(zg) of 1999 Act. By virtue of Section



28 of 1999 Act, Plaintiff has acquired statutory right to exclusively use the mark BATA and to restrain third parties from infringing the same. Due to extensive and continuous use, Plaintiff also has common law rights in the mark. It is *prima facie* evident that Defendants No. 1 and 2 are selling their product i.e., shoes using an identical mark BATA. The marks being identical and the rival goods being identical, the trade channels and the consumers will be common and confusion is to be presumed and *prima facie* case of infringement is made out under Section 29(3) of 1999 Act. The intent behind using identical mark for identical goods is to misrepresent to the public that the goods belong to the Plaintiff or are being sold owing to some association thereof. This is causing irreparable harm and injury to the formidable goodwill and reputation earned by the Plaintiff over the years and amounts to passing off. Screenshots showing the impugned products bearing the mark BATA are as follows:-





25. Accordingly, till the next date of hearing, Defendants No. 1 and 2 including John Doe(s) and all others acting on their behalf are restrained from selling, offering for sale any footwear/goods, advertising or promoting any product under the trademark BATA, amounting to infringement trademark and/or passing off.

26. It is further directed that Defendant No. 3/Flipkart Internet Pvt. Ltd. shall take down the URLs mentioned in **Annexure-A** to this order within a period of 36 hours from the date of receipt of copy of this order.

27. Plaintiff shall comply with the provisions of Order XXXIX Rule 3 CPC within a period of two weeks from today.
