1. Heard learned counsel for the petitioner, Mr. Shashi Prakash, learned ASGI assisted by Mr. Krishna Agrawal for Union of India, Mr. Anoop Trivedi, learned AAG assisted by Mr. Ravi Shanker Pandey, ACSC for State.

2. In pursuance of earlier order, Mr. Saurabh Suman Shardool, Registrar, Goods & Services Tax Appellate Tribunal, Principal Bench, New Delhi is present before this Court.
