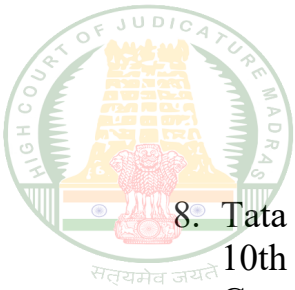

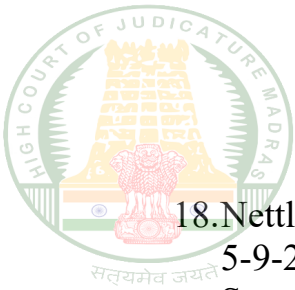

To grant an order of ad interim injunction restraining the Respondents/Defendants 1 to 29 from infringing the cinematographic film AWARAPAN 2 and said work be directed to block all websites/web pages and future websites (including their prefix and suffix) and those Non Compliant websites mentioned in Schedule A hosting contents that relate to Plaintiffs copyright protected cinematographic film AWARAPAN 2 in any manner, thereby restraining the unauthorised copying, transmission, communication or mark available or display or release or show or upload or download or exhibit or play and/or in any manner communicate in and/or through their services immediate of receipt of details of such infringing websites/webpages in writing, pending disposal of the above suit.

OA No. 838 of 2026

To grant an order of ad-interim injunction restraining the Respondents 1 -4/Defendants 30-33 from infringing the cinematographic film AWARAPAN 2 by themselves their partners/proprietor/directors, heirs representatives, successors in business, assigns, distributors, agents, servants or anyone claiming through them or under them from infringing the Plaintiffs copyrighted cinematographic film AWARAPAN 2 by copying, recording, reproducing or allowing Camcording or allowing others to transmit, communicate or make available or distributing or duplicating or displaying or releasing or showing or uploading or downloading or exhibiting or playing and/or in any manner or downloading or exhibiting or playing and /or in any manner whatsoever from communicating the cinematographic film AWARAPAN 2 and said work manner without a proper license from the Plaintiff or in any other manner which would violate/infringe the plaintiffs copyrighted cinematographic film AWARAPAN 2 through different mediums including but not limited to CD, DVD, Blu-ray disc., VCD, cable TV, Direct to



home services, internet services multimedia messaging services, pen drives, internet services, multimedia messaging services, pen drives, hard drives, tapes, DAS, satellite Conditional Access Systems or in any other medium/manner whatsoever, pending disposal of the above suit.

Common Order

In a suit seeking remedies in respect of the apprehended infringement of the plaintiff's copyright in the cinematographic film titled "AWARAPAN 2", the plaintiff has presented these two Original Application Nos.837 and 838 of 2026, seeking for the relief as stated therein.

2. As evidence of the plaintiff's ownership of the copyright, the plaintiff has filed CBFC certificate describing the plaintiff as the Producer. The promotional material reveals that the movie is slated for release on 14/8/2026.

3. In matter of this nature, it is likely that irreversible injury will occur, unless unlawful broadcast is prevented. At the same time, in view of the expensive nature of the relief claimed, it is possible that the legitimate business interest of one or more respondents may be affected. Therefore, it is necessary that the plaintiff shall indemnify in respect thereof.



4. Subject to this condition, order of ad interim injunction as prayed for are granted upto 11/9/2026. Issue notice to the respondents returnable by 11/9/2026. Private notice is also permitted through speed post with acknowledgement due. The applicant shall comply with Order XXXIX Rule 3 of the Code of Civil Procedure.

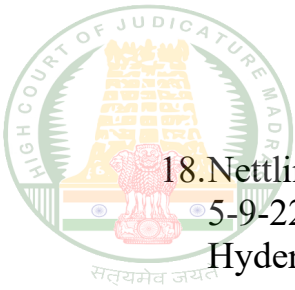

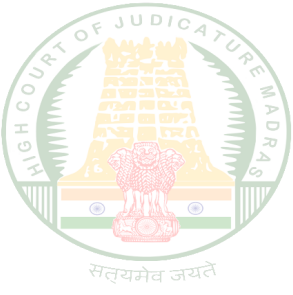
