**I.A. 21560/2026 (for pre-institution mediation)**

1. This application is filed on behalf of the Plaintiff under Section 12A of the Commercial Courts Act, 2015 read with Section 151 CPC seeking exemption from Pre-Institution Mediation.
2. Having regard to the facts of the present case wherein urgent relief is prayed for and in light of the judgment of Supreme Court in *Yamini*



***Manohar v. T.K.D. Keerthi, (2024) 5 SCC 815***, as also Division Bench of this Court in ***Chandra Kishore Chaurasia v. RA Perfumery Works Private Ltd., 2022 SCC OnLine Del 3529***, exemption is granted to the Plaintiff from Pre-Institution Mediation.

3. Application is allowed and disposed of

**I.A. 21561/2026 (u/S 151 CPC)**

4. This application is filed by the Plaintiff seeking exemption from filing certificate/affidavit under Section 63(4)(c) of the Bharatiya Sakshya Adhiniyam, 2023 in respect of the electronic records/Annexure-A filed along with the present suit.

5. Issue notice.

6. Counsels, as above, accept notice on behalf of the respective Defendants.

7. Notice be issued to remaining Defendants through all permissible modes, returnable before Court on 18.12.2026.

**I.A. 21562/2026 (u/S 80(2) r/w Section 151 CPC)**

8. This application is filed on behalf of Plaintiff seeking exemption from serving two months advance notice on Defendant No.11/MeitY and Defendant No. 12/DoT.

9. For the reasons stated in the application, the same is allowed, exempting Plaintiff from serving two months advance notice on Defendant No.11/MeitY and Defendant No.12/DoT.

10. Application stands disposed of.

**I.A. 21563/2026 (u/S 149 r/w Section 151 CPC)**

11. This application is filed on behalf of Plaintiff seeking extension of time by two weeks for filing the Court fees.



12. For the reasons stated in the application, the same is allowed granting Plaintiff two weeks to file the requisite Court fees.

13. Application stands disposed of.

**CS(COMM) 869/2026**

14. Let plaint be registered as a suit.

15. Issue summons.

16. Counsels, as above, accept summons on behalf of the respective Defendants.

17. Upon filing of process fee, issue summons to remaining Defendants through all permissible modes, returnable before the learned Joint Registrar on 17.09.2026.

18. Summons shall state that the written statements shall be filed by remaining Defendants within 30 days from the receipt of summons along with affidavits of admission/denial of the documents filed by the Plaintiff.

19. It will be open to the Plaintiff to file replications within 30 days from the date of receipt of written statements along with affidavits of admission/denial of documents filed by remaining Defendants.

20. If any of the parties wish to seek inspection of any documents, the same be sought and given within the timeline prescribed in Delhi High Court (Original Side) Rules, 2018.

21. Learned Joint Registrar will carry out admission/denial of documents and marking of exhibits.

**I.A. 21559/2026 (u/O XXXIX Rules 1 and 2 r/w Section 151 CPC)**

22. This application is filed on behalf of the Plaintiff under Order XXXIX Rules 1 and 2 read with Section 151 CPC for grant of *ex parte* ad interim injunction.



23. Issue notice.

24. Counsels, as above, accept notice on behalf of the respective Defendants.

25. Notice be issued to remaining Defendants through all permissible modes, returnable before Court on 18.12.2026.

26. Case of Plaintiff as set out in the plaint is that Plaintiff is a prominent Indian actress, performer and public personality associated with the Hindi film industry and is widely recognised across cinema, fashion, lifestyle and digital media. Following completion of her professional acting education, Plaintiff formally commenced her acting career and through successive professional engagements, gradually developed a distinct public persona separate from her familial associations. Her participation in feature films, promotional campaigns, editorial interviews, fashion events, luxury brand engagements, award functions and commercial collaborations has significantly enhanced the recognition attached to Plaintiff's name and likeness and her name, image, appearance and overall persona are independently recognised within the entertainment industry and the advertising ecosystem.

27. It is stated that Plaintiff was born on 05.11.2000 into one of the most distinguished and widely respected families in the Indian film industry. Growing up in such an environment, Plaintiff was exposed from an early age to the creative, artistic and professional ecosystem of filmmaking, cinema, advertising, production, media interactions and public life and even prior to making her acting debut, Plaintiff had become a familiar face to the Indian public owing to her frequent appearances alongside members of her family at various public events, film premieres, award ceremonies, charitable



functions, cultural programmes and entertainment industry gatherings. Plaintiff chose to complete her professional acting education before accepting acting assignments. Plaintiff pursued formal acting studies at the New York Film Academy, an internationally recognised institution known for its specialised programmes in acting, filmmaking and performing arts. Plaintiff attended the New York Film Academy in 2019 and underwent structured training in acting methodology.

28. It is stated that Plaintiff formally entered the Indian entertainment industry in the Netflix Original Film '*The Archies*', globally released on 07.12.2023, wherein Plaintiff portrayed the iconic character '*Betty Cooper*' and Plaintiff's subsequent projects include '*Loveyapa*' and '*Nadaaniyan*'. Plaintiff has consistently remained engaged with the Indian entertainment industry through participation in film promotions, industry events, award ceremonies, launch events, media conclaves, fashion exhibitions and cultural programmes, which appearances have been extensively covered by newspapers, entertainment publications, television broadcasters, digital media platforms and photographers specialising in entertainment reporting.

29. It is stated that Plaintiff has been the recipient of several awards, recognitions and nominations at reputed award platforms, including *inter alia* Editor's Choice – Best OTT Debut Actress for '*The Archies*' at the Indian Telly Streaming Awards (2024); Most Promising Debutant of the Year for '*Loveyapa*' at the Bollywood Hungama Style Icons Awards (2025); Rising Star of the Year (Female) for '*Loveyapa*' at the ELLE Beauty Awards (2025); Winner – Best Debut Actress for '*The Archies*' at the e4m Play Streaming Media Awards (2024); and Gen Z Style Star of the Year at the Grazia Young Fashion Awards (2025).



30. It is stated that Plaintiff has received extensive editorial recognition from leading newspapers, fashion magazines, lifestyle publications and entertainment media and has featured in reputed publications including Vogue India, Harper's Bazaar India, Elle India, Grazia India, Cosmopolitan India, Filmfare, Hindustan Times and Lifestyle Asia through interviews, digital features, fashion editorials and professional profiles. Plaintiff has further participated in prominent fashion events, designer showcases and luxury brand initiatives, reflecting her growing influence within the fashion, lifestyle and entertainment industries. Such independent editorial recognition constitutes objective evidence of Plaintiff's increasing commercial appeal, marketability and public influence.

31. It is stated that as a consequence of her continued professional engagements, members of the public increasingly identify Plaintiff by reference to her acting skills and career, media presence, fashion identity and commercial collaborations and Plaintiff's name and image have progressively become source-identifiers within the entertainment and advertising industries. Members of the public instantly recognise the Plaintiff through her facial features, photographs, digital content, public appearances and in the promotional campaigns. The cumulative effect of Plaintiff's acting assignments, media visibility, editorial recognition, fashion engagements and promotional activities has been the creation of substantial goodwill associated exclusively with her personality and consequently, Plaintiff's name, likeness, image, public appearances and digital persona possess measurable commercial value, capable of attracting audiences, influencing consumer behaviour and enhancing the promotional effectiveness of commercial campaigns.



32. It is stated that Plaintiff has entered into commercial collaborations with well known consumer and lifestyle brands, including Myntra, Converse Shoes and Sol de Janeiro, amongst others, which have consciously chosen to associate their products and services with Plaintiff's public image, contemporary appeal and growing influence. Plaintiff's personality, name, image, etc. carry immense goodwill and commercial value and are treated as a source indicator and for this reason, Plaintiff is one of the most sought-after emerging personalities for brand endorsements, her endorsement portfolio spanning reputed domestic and international brands including Myntra in fashion and lifestyle, Converse in footwear and lifestyle, Sol de Janeiro in beauty and personal care and Cava Athleisure in activewear and fitness apparel. Every authorised endorsement, promotional campaign, editorial collaboration and public appearance undertaken by Plaintiff reflects the commercial value attached to her identity and the willingness of third parties to invest substantial resources in associating themselves with her persona.

33. It is stated that Plaintiff maintains an official presence across prominent social media platforms through verified accounts that function as primary channels for interaction with audiences, dissemination of professional updates and engagement with commercial partners and, in particular, maintains a verified Instagram account having 2 million followers, comprising followers from India and abroad. Plaintiff's extensive public reach, influence and engagement have made her a highly sought-after personality for brand endorsements, promotional campaigns, editorial collaborations and commercial associations, thereby significantly enhancing the commercial value attached to her personality.



34. It is stated that Plaintiff's rights in the present suit encompass: (a) Personality Rights and Publicity Rights, which have developed from the Right to Privacy and are protectable under Articles 19 and 21 of the Constitution of India, including her name 'Khushi Kapoor', signature, initials, styles, likeness, photographs/images and movie stills, videos, performances and characters associated with her, voice and other attributes which are distinctive and uniquely associated only with Plaintiff; (b) rights under the Copyright Act, 1957 ('1957 Act'), Plaintiff being the owner and/or entitled person in respect of a body of works and performances in which copyright and allied rights subsist, including photographs, literary, musical, artistic and dramatic works, sound recordings, cinematographic films, audiovisual material and performances, by virtue of Sections 38, 38A and 38B of the said Act, granting performers the right to claim authorship and to restrain any distortion, mutilation or other modification of their performance that would be prejudicial to their reputation; (c) rights under the Trade Marks Act, 1999 to protect marks, both registered and unregistered, including her name, initials and other identifying indicia in which Plaintiff has acquired rights through use, recognition and association; and (d) common law rights to restrain third parties from passing off and misappropriating the standing, public recognition and market association attached to her personality.

35. It is stated Defendant No. 1 are John Does, i.e., unknown persons/entities and the infringing activities in the present suit fall in two categories i.e.: (a) sale of infringing products i.e., posters bearing Plaintiff's name, image and likeness; and (b) AI-generated obscene images/videos designed to attract viewership through sensationalism and prurience and is



causing grave injury to Plaintiff's reputation in the society. Defendant No.2/Meta Platforms, Inc. owns and operates, *inter alia*, the social networking platforms Facebook and Instagram, on which numerous fake profiles, impersonating accounts and AI-generated/deepfake content unlawfully depicting Plaintiff have been identified. Defendant No. 3/Google LLC owns and operates, *inter alia*, the video-sharing platform YouTube, upon which unauthorised content concerning Plaintiff, including impersonating channels and misleading digital content, has been made available without Plaintiff's consent and also owns and operates the GIF platform <https://tenor.com>, on which unauthorised GIFs and stickers featuring Plaintiff's name, image, likeness and other personality attributes have been made available for download and sharing without Plaintiff's consent or authorisation.

36. It is stated that Defendant No. 4/X Corp. owns and operates the social media platform X, on which numerous impersonating accounts and fake profiles using Plaintiff's name and identity have been identified. Defendant No. 5/Pinterest, Inc. owns and operates the online visual discovery platform Pinterest, on which AI-generated and digitally manipulated content concerning Plaintiff has been identified. Defendant No. 6/Reddit, Inc. owns and operates the online discussion and content aggregation platform [www.reddit.com](http://www.reddit.com), which enables users to create, publish, host, disseminate and publicly interact with user-generated posts, comments, images and other digital content and Plaintiff has identified several discussion threads and posts hosted on the said platform, which unauthorisedly exploit Plaintiff's name, image, likeness and other personality attributes without her consent.



37. It is stated that Defendant No. 7 is the unknown person(s) and/or entity/entities who own, operate, control and administer the Facebook page titled 'Khushi Kapoor' accessible at the URL <https://www.facebook.com/khushikapoor/>, which page has approximately 567,000 followers and is described as a 'Fashion stylist' page and is systematically posting content using Plaintiff's name, image, likeness and personality attributes without Plaintiff's consent, authorisation or knowledge. Impersonation undertaken by Defendant No. 7 is particularly egregious as the follower base of the said page is approximately 28% of Plaintiff's own verified Instagram following, which volume demonstrates that a substantial section of the public has been deceived into believing that the said page is operated by or authorised by or officially associated with the Plaintiff. The page regularly publishes posts incorporating Plaintiff's name, photographs, likeness and personality attributes, including posts relating to Plaintiff's family, public appearances and professional engagements, thereby creating a false impression of authenticity and official association and each additional follower, post, comment and interaction deepens the deception and expands the reach of the unauthorised content.

38. It is stated that Defendant No. 8/SeaArt, Inc. is a company incorporated in Hong Kong which owns and operates the website [www.seaart.ai](http://www.seaart.ai), an Artificial Intelligence-powered online platform that enables users to generate, create, modify, synthesise and disseminate AI-generated images, videos and other digital content using text prompts, image inputs and other reference materials and which permits users to search for and generate AI-created visual depictions of identified individuals, including Plaintiff, by entering Plaintiff's name 'Khushi Kapoor' as a search term or



prompt. Upon accessing the platform, Plaintiff discovered that [www.seaart.ai](http://www.seaart.ai) hosts a dedicated search results page at <https://www.seaart.ai/search/Khushi%20kapoor> displaying numerous AI-generated images purporting to depict Plaintiff. The platform is designed to monetise user engagement through subscriptions, premium features and advertising and that by enabling users to generate AI-created depictions of Plaintiff using her name and identity as inputs, Defendant No. 8 is commercially exploiting Plaintiff's personality and publicity rights for its own financial benefit, the AI-generated content being capable of downloading, sharing, modifying and further dissemination by users, thereby multiplying the infringement.

39. It is stated that Defendant No. 9/JanitorAI, Inc. is a company incorporated in the State of Delaware, United States of America and operates an online platform located at <https://janitorai.com/>, where it has deployed user-customisable AI chatbots that can present themselves as real-life personalities and generate obscene and objectionable material. Platform operated by Defendant No. 9 hosts multiple chatbots presenting as Plaintiff and imitating Plaintiff's likeness and users can interact with the Infringing Chatbots as if they were interacting with Plaintiff herself, including generating outputs that are, in many cases, obscene, lewd or otherwise objectionable. Plaintiff has not licensed or authorised her likeness, including her voice, images, name or any other personality attribute, to be used to generate outputs from the Infringing Chatbots and the platform is illegally monetising as also commercially exploiting Plaintiff's rights in her personality attributes.

40. It is stated that Defendant No. 10/Living Media India Limited owns



and operates the website [www.indiacontent.in](http://www.indiacontent.in), which functions as a commercial image licensing and stock photography platform offering photographs of public figures, celebrities and newsmakers for commercial licensing, sale and dissemination and which enables users to search, browse, purchase and license photographs depicting identified individuals for commercial use in advertisements, publications, digital media and other commercial contexts. Upon investigation, Plaintiff has identified numerous photographs depicting her at various public appearances, film promotions, fashion events, screenings and other professional engagements hosted on the said platform and made available for commercial licensing and sale without Plaintiff's consent, licence or authorisation. It is urged that Plaintiff has neither authorised nor licensed Defendant No. 10 to reproduce, host, display, offer for sale, license or commercially exploit any photographs depicting the Plaintiff and this amounts to infringement and misappropriation. Defendant No. 11/Ministry of Electronics and Information Technology (MeitY) and Defendant No. 12/Department of Telecommunications (DoT) have been impleaded to facilitate effective implementation of any directions issued by this Court.

41. Learned counsel for the Plaintiff submits that Plaintiff is an actress and public personality who has since built a professional identity through her performances in '*The Archies*', '*Loveyapa*' and '*Nadaaniyan*'. Plaintiff has been the recipient of several awards and nominations, has extensively featured in leading editorial and fashion publications and has a verified social media following of 2 million on Instagram. Plaintiff's name, image and likeness carry considerable goodwill and commercial value and she is a sought-after personality for brand endorsements, having collaborated with



brands such as Myntra, Converse and Sol de Janeiro. Elements of Plaintiff's persona are being unlawfully used by Defendants without her permission or authorisation, in order to make unjust commercial gains and by falsely suggesting association with or endorsement by Plaintiff. Counsel further submits, on instructions, that without prejudice to Plaintiff's right to press the remaining reliefs at the appropriate stage, at this stage Plaintiff restricts the relief to take down of the following URLs, outlined in Annexure-A to the plaint:-

- (a) URLs at serial nos. 1 to 61;
- (b) URLs at serial nos. 62 to 71;
- (c) URLs at serial nos. 177 to 182;
- (d) URLs at serial nos. 183 and 184; and
- (e) URLs at serial nos. 185 to 275.

42. Having heard learned Senior Counsel for the Plaintiff and upon perusal of the screenshots and other impugned contents, I am of the view that Plaintiff has made out a prima facie for grant of *ex parte* ad interim injunction against the Defendants. Balance of convenience lies in favour of the Plaintiff and she is likely to suffer irreparable harm in case the interim injunction, as prayed for, is not granted.

43. Plaintiff is an actress in the Indian film industry who made her debut in the Netflix Original Film 'The Archies' and has thereafter featured in 'Loveyapa' and 'Nadaanian'. Plaintiff is a recipient of several awards and nominations and has received wide editorial recognition in publications such as Vogue India, Harper's Bazaar India, Elle India and Grazia India. As averred, Plaintiff has a verified following of 2 million on Instagram and has been engaged as a brand ambassador by many well known brands across



fashion industry. Plaintiff has generated independent goodwill and recognition owing to her work and her name, image and likeness function as source indicators possessing measurable commercial value. There is no gainsaying that Plaintiff's name 'Khushi Kapoor' and her image, voice, likeness and other attributes of her personality have acquired unique distinctiveness and are associated with her instantly by members of public. Plaintiff has a right to protect her personality rights and consequentially to restrain third parties from using, misappropriating and/or exploiting in any manner, without her consent and authorization, the personality attributes. Personality rights have been recognised and protected by this Court in several orders passed from time to time.

44. In *D.M. Entertainment v. Baby Gift House*, 2010 SCC OnLine Del 4790; *Anil Kapoor v. Simply Life India*, 2023 SCC Online Del 6914; and *Jaikishan Kakubhai Saraf v. Peppy Store*, 2024 SCC OnLine Del 3664, this Court has consistently held that unauthorised use of person's name, image or other distinctive attributes for commercial purposes constitutes an infringement of his rights, amounts to dilution of individual's unique identity and leads to unearned commercial gain by others. It is well settled that where such personality rights are established, the individual is entitled to protection by way of injunction against their unauthorised use or exploitation. When attributes of famous personalities are used unauthorisedly, it leads not only to commercial detriment but also impacts his/her right to privacy/personality and live with dignity. Defendant No.1/John Doe have reproduced, published, displayed, communicated, hosted and commercially exploited Plaintiff's photographs, film stills, promotional images, likeness, name and other distinctive personality



attributes across digital platforms without Plaintiff's consent or authorization, for unlawful gains. Defendant No. 1 have also uploaded pornographic, obscene and sexually explicit content with morphed, manipulated and superimposed images, likeness and other personality attributes of the Plaintiff. Defendant No.10 is operating a commercial image licensing/stock photography platform hosting numerous photographs of the Plaintiff and offering them for commercial licensing and sale as licensable digital assets without Plaintiff's consent, licence or authorization, which amounts to unauthorised commercial exploitation of her likeness and personality attributes and violation of copyright.

45. Accordingly, till the next date of hearing:-

- (a) Defendants No. 1/John Doe, 7, 8, 9 and 10, are restrained from violating Plaintiff's Personality/Publicity Rights by utilizing and/or in any manner directly and/or indirectly, using or exploiting or misappropriating Plaintiff's (a) name 'Khushi Kapoor'; (b) image and likeness; and (c) any other attributes of her persona, which are exclusively identifiable with her, for any commercial and/or personal gains and/or otherwise by exploiting them in any manner whatsoever, without Plaintiff's consent and/or authorization including through the use of any technology including but not limited to Artificial Intelligence, Generative Artificial Intelligence, Machine Learning, Deepfakes, AI Chatbots, Face Morphing, Voice Cloning, Synthetic Media, on any medium and/or formats;
- (b) Defendant No. 11/MeitY and Defendant No. 12/DoT shall issue notifications to the relevant ISPs and TSPs for takedown of URLs mentioned at serial nos. 1-61; 62-71; 177-182; 183-184 in



**Annexure-A** to this order, within 36 hours from the date of receipt of this order;

(c) Defendant No. 10/Living Media India Pvt. Ltd. shall takedown URLs mentioned in serial nos. 185-275 in **Annexure-A** to this order within 36 hours from the date of receipt of this order.

46. Plaintiff shall comply with the provisions of Order XXXIX Rule 3 CPC within a period of two weeks from today.
