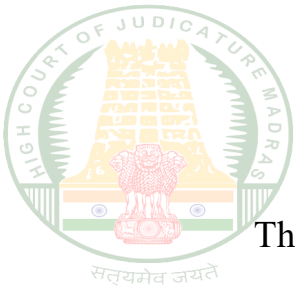

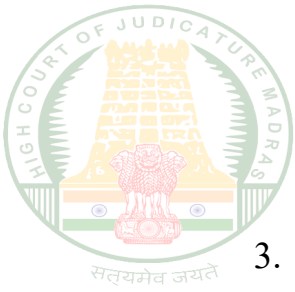

The Arbitration Application in Arb.Appln.No.944 of 2026 has been filed to direct the Respondent, his men, agents, servants or any person acting on his behalf to render a true and faithful account of all revenues, monies, and consideration received or receivable from the exploitation, release, screening, distribution or exhibition of the Tamil feature film titled “AGNI SIRAGUGAL” starring Vijay Antony, Arun Vijay, Akshara Haasan and others, directed by Naveen, in any medium whatsoever including but not limited to theatrical release and/or through Over-the-Top OTT platforms, and further direct the Respondent to deposit the entire proceeds arising therefrom to the credit of these proceedings, pending disposal of the present petition and/or pending arbitration.

The Arbitration Application in Arb.Appln.No.945 of 2026 has been filed to direct the Respondent to furnish security to the satisfaction of this Hon'ble Court to secure the claim amount of Rs. 2,00,00,000/- (Rupees Two Crores only) together with interest at the rate of 36% per annum from the date of disbursement until the date of payment, to remain in force pending the arbitral proceedings and until the enforcement of the award that may be passed therein.

4. Heard both sides.

5. An affidavit had been filed by the respondent, admitting its liability as claimed by the applicant and had also given an undertaking before this Court vide its affidavit dated 30.06.2026 that the respondent should not release, distribute, exploit, exhibit or otherwise commercially exploit the Tamil feature film "AGNI SIRAGUGAL", without clearing the dues of the applicant, including any third party interest in the film

6.. The said affidavit is taken on record.

7. It is also brought to the notice of this Court that a Section 11 application has been moved before this Court and is awaiting orders.

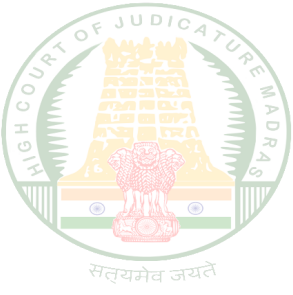
