UPON hearing the counsel the Court made the following  
O R D E R

1. Heard Mr. Shyam Divan, Mr. Navin Pahwa & Mr. Gaurav Agarwal, the learned senior counsel appearing for the petitioners, and Mr. Mukul Rohtagi and Mr. Puneet Bali, the learned senior counsel appearing for the respondent no.1.
2. Issue notice returnable on 11.2.2026.
3. Dasti service, in addition, is permitted.
4. We direct the petitioners to disclose their movable and immovable assets on Oath before this Court within a period of two weeks from today.
5. We further direct the petitioners to maintain *status quo* as regards all their movable and immovable assets till the next date of hearing.
6. We direct the Managing Director of the petitioners to file a personal undertaking before this Court that status quo shall be maintained, insofar as the assets owned by the petitioners are concerned, within a period of two weeks.

7. We clarify that the order of status quo shall not impact the normal running of the company.

8. One copy of the disclosure shall be provide at the earliest to the learned advocate-on-record appearing for the respondent no.1.

9. Mr. Rohtagi, the learned senior counsel, makes a statement that since the matter is before this Court his client shall not proceed with the execution of the arbitral awards.

10. Liberty for both the sides to file their submissions.
